# The 181<sup>st</sup> Annual Meeting of the Mid-Atlantic Baptist Network

## Session I – Sunday Evening – November 13, 2016 Fitzgerald Ballroom

- 1. **Call to Order** At 6:30 p.m., President Bill Warren, Pastor, Allen Memorial Baptist Church, Salisbury, Md., welcomed the gathering and officially called the 181st Annual Meeting of the Mid-Atlantic Baptist Network to order. President Warren opened the meeting with prayer and then introduced Richard Logsdon.
- 2. **Welcome** Richard Logsdon, Order of Business Committee Chairman, welcomed messengers and guests.
